#### 1. Attendance

#### 2. Minutes of the previous meeting

James explains the budget to the executive committee, as not all of them had read the budget previously. Still waiting on a \$250 hall bond to be returned.

James moves to retroactively approve the budget for Summer Science, and the reimbursements associated with it.

For Summer Science, as none of the leadership team had a first aid qualification, James and Tim attended a first aid course, which was \$79 each.

The executive committee discusses whether first aid qualifications should be reimbursed by YSA Melbourne. Ricardo believes that this would fall under operational costs. However, Michael raises that it may set an unreasonable expectation to have YSA Melbourne reimburse all first aid qualifications in YSA Melbourne.

James suggests a subsidy as an alternative - with a maximum cap for the organisation to spend on first aid within a year. Ricardo suggests the subsidy to be done on an event basis as opposed to a yearly cap. There is a discussion about when it is important to have first aid at events - not just TCSE but also potentially events.

Garth moves a motion to approve and reimburse the expense by James and Tim for first aid training for Summer Science 2017 for the sum of \$158 (\$79 respectively), to be paid via EFT. Motion passes.
