#### 1. Opening and Attendance

#### 2. Minutes of the Previous Meeting

Ice skating:

Ice skating was well received this year. We had 50 attendees in total (actual number that

attended in person is lower but unknown to me personally). Good things was the provision

of the function room this year round, this was unexpected and not something that had been

personally requested on behalf of YSA. The staff in general were pretty flexible allowing

to skate well past our allocated time of 2:30PM.

There were a couple of worries, a number of injuries they occur on the ice rink. Notably a

head injury with Faith and another with one of our participants in a Sling.

In terms of organisation, the community engagement officer at the rink was friendly and

helpful if not a bit hard to get hold of. Concern has been raised about the costing of the

event with prices increasing steadily over the last few years. It has been agreed upon that

this event would cease to be sustainable should upfront costs to participants (price someone pays on Tidy) exceeds \$25 and I would recommend that the next committee look

into alternatives for the February social.
